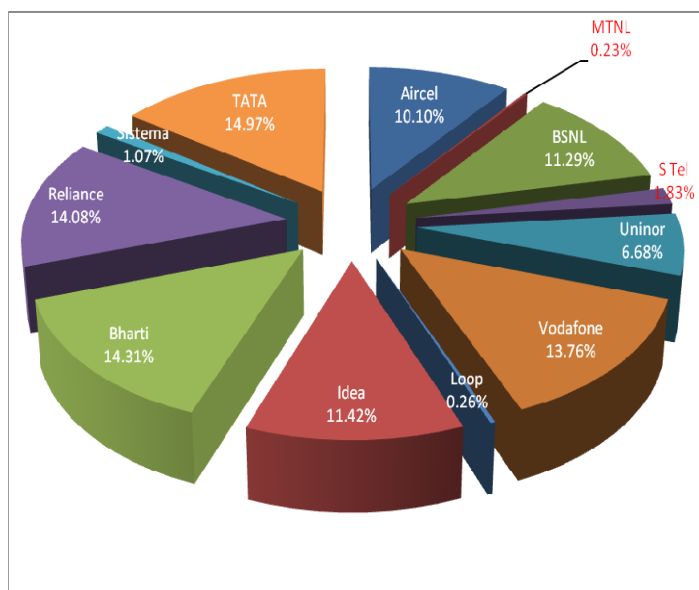

V. TRAI DIRECTION

- A. On 26th February 2010, TRAI issued a direction to ensure compliance of the terms and conditions of the license regarding confidentiality of information of subscribers and privacy of communications. TRAI Directs the Service Providers to :-

- i. *to ensure confidentiality of information as provided in the license conditions*
- ii. *to put in place an appropriate mechanisms so as to prevent breach of confidentiality of information of the subscribers and privacy of communication*
- iii. *to furnish to the Authority, within fifteen days of issuance of this Direction, the details of steps taken by the service provider to safeguard the confidentiality of information of subscribers and privacy of communications*

- B. On 10th February 2010, TRAI issued a direction with a list of Unique Porting codes (UPC) for service providers and service areas with regard to MNP.

- i. *UPC consist of 8 characters with first two denoting service provider code and service area code respectively and remaining 6 characters to contain 1 to 9, A-N & P-Z only.*
- ii. *Small letters and alphabet 'O' shall not be allowed*
- iii. *Porting code allocated shall be valid for fifteen days from the date of request or number is ported out (whichever is earlier).*
- iv. *SMS code for requesting Unique Porting Code shall be 'PORT' followed by <space> followed by ten digit mobile number*

- A. On 19th February 2010, TRAI placed on its website a proposal received by the Authority on "Allocations of Spectrum for Technologies such as DECT, to meet the Residential and Enterprise Intra-Telecommunication Requirements".

TRAI had requested Stakeholders comments on this by 30th April 2010.

- B. On 10th February 2010, TRAI has placed a notice on its website seeking comments from Stake Holders for the pre-consultation of all aspects of 4G which could be relevant to policy making or regulation.

- A. On 26th February 2010, AUSPI submitted its response on TRAI Consultation Paper on Efficient utilization of Numbering to TRAI.
- B. On 26th February 2010, AUSPI submitted a letter to Secretary (T), DoT requesting for EVDO spectrum in 800 MHz and 1900 MHz band to be included for auction by revising the present NIA.
- C. On 19th February 2010, AUSPI submitted a letter to Administrator, USOF requesting:-
 - i. *The existing scheme of RDEL may kindly be continued for another two years.*
 - ii. *The existing scheme may be slightly modified to support R DEL data related CAPEX and OPEX requirements for enabling internet access through wireless data connections in these areas.*
- D. On 18th February 2010, AUSPI submitted its comments to Secretary (T), DoT regarding an incumbent GSM Service Provider's contention on Spectrum holding and usage Charges for CDMA.
- E. On 15th February 2010, AUSPI submitted a letter to Hon'ble Minister of Communications and IT requesting his intervention for doing away of rollout obligation for J&K, Assam & North East.
- F. On 9th February 2010 AUSPI wrote a letter to Editor, The Financial Express with regard to an article published in their News Paper which caused misleading impression against the CDMA operators about spectrum holdings and charges.

- G. On 8th February 2010 AUSPI submitted a letter to Secretary (T), DoT seeking clarification on certain issues with regard to Amendments to the license in respect to Security related concerns for expansion of Telecom Services in various zones of the country.
- H. On 5th February 2010 AUSPI submitted a letter to Secretary (T), DoT, requesting not to change the Basic Service Number Levels of our Member Service Providers, which will disturb their basic service operations and suggested that instead of doing so DoT should go for a permanent numbering solution.
- I. On 4th February 2010 AUSPI submitted a letter to Dr. Sam Pitroda, Advisor to Hon'ble Prime Minister requesting to Consider use of UHF Band V (698 MHz – 806 MHz) for deployment of 4G technologies like WiMAX & LTE and 582 MHz – 698 MHz for Mobile TV.
- J. On 3rd February 2010, AUSPI submitted a letter to Secretary (T), DoT, with reference to DoT Committee on Mobile Banking requesting that:-
- i. *Mobile companies should be allowed to become business correspondents (BC) by permitting all Unified Access Service Licensees and CMTS licensees to become Business Correspondents.*
 - i. *Mobile prepaid instrument should be converted from Semiclosed payment system to the Open Payment System.*
- K. A letter similar to 'J' was submitted to Department of Payment and Settlement Systems, Reserve Bank of India.
- L. On 3rd February 2010, AUSPI submitted a letter to Secretary (T), DoT, requesting for ensuring rollout of MNP is completed in the timeline specified by DOT.
- M. On 2nd February 2010 AUSPI wrote a letter to Editor, The Business Standard with regard to an article published in their News Paper which caused misleading impression against the CDMA operators about spectrum holdings and charges.

AUSPI clarified each and every point mentioned in the Article and requested the Editor to Publish this letter in the News Paper so that the readers have the benefit of correct and complete information on the subject.

- N. On 1st February 2010, AUSPI submitted a letter to TRAI requesting the Authority to resolve certain issues like Interconnect Agreement, Cross Connection Charges, Bulk Porting, Dispute Resolution Mechanism etc. for timely implementation of Mobile Number Portability.

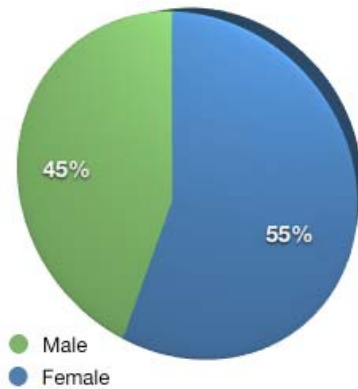
