III. TRAI CONSULTATION PAPER

A. On 17th March 2010, TRAI released Consultation Paper on "Collocation Charges". The Consultation Paper takes up the following important issues for deliberations:-

- i. *Terms and conditions for collocation*
- ii. *Measures to ensure transparent and non-discriminatory treatment in pricing and provisioning of collocation facilities.*
- iii. *Sharing of cost of collocation by the seeker and provider.*

Stakeholders are requested to submit their comments by 17th May 2010 and counter comments by 3rd June 2010.

IV. TRAI CIRCULAR / LETTERS / NOTICE

A. On 19th March 2010, TRAI vide letter no. 305-20/2009-QoS intimated the Association regarding constitution of a Committee to study problems of prepaid customers as raised by Consumer Advocacy Group.

V. TRAI MEETING

A. The first meeting of the committee constituted to study the problems of prepaid customers was held on 31st March 2010 at 1100 hrs along with Consumer Advocacy Group in the Conference Room, TRAI under the Chairmanship of Secretary TRAI.

VI. DOT LETTERS

A. DoT vide letter no. 10-15/09-AS-II dated 31st March 2010 intimated the Association about the meeting called by Minister of Communication and IT on 1st April 2010 at 1100 hrs in the Conference Hall to discuss the issues regarding security clearance before placement of purchase orders for procuring telecom equipment / Software.

B. DoT vide letter no. 800-50/2009-VAS dated 30.03.2010 indicated the time frame for completing various activities for MNP Implementation.

C. WPC vide letter no. R-11014/24/2007-LR Vol II/140 dated 30th March 2010 sought certain information from Service Providers for reconciliation of the microwave backbone charges consequent to the judgment of Hon'ble TDSAT as follows:-

- i. *Date of operation of links established prior to 31.05.2005.*
- ii. *Date of SACFA clearance w.e.f. 01.04.05*
- iii. *Details of the links for which no SACFA clearance applied /obtained prior to 15.04.09.*

D. On 30th March 2010, DOT has placed on its website the list of Pre Qualified Bidders for 3G/BWA Auction.

E. On 25^h March 2010, DOT has placed on its website ownership details regarding 3G/BWA Auction.

F. TEC vide email dated 25th March 2010 sought Comments on "draft migration plan from IPv4 to IPv6 in India" proposed for service providers.

G. DoT vide letter no. No.10-15/2009-AS-III/ dated 18th March 2010 intimated immediate compliance of the guidelines mentioned in the letter regarding Security clearance before placement of purchase order for procuring telecom equipment / software.

H. DoT vide letter no. 6/10/2006-Policy-I (Pt.) dated 9th March 2010 requested the Association's suggestions / comments regarding installation of communication towers in NDMC area on the observations of DUAC and response of MTNL.

- I. DoT vide letter no. 12-31/2008/WTO(IP) dated 4th March 2010 sought details from the Service Providers regarding trade distortive effects encountered by them in the export of services because of subsidies in service trade provided by other countries.

VII. DOT MEETINGS

- A. DCC meeting of Switching Division was held on 12th March 2010 at New Committee Room, 3rd floor, K.L. Bhawan, TEC.
- B. TEC Meeting regarding implementation of MNP was held on 9th March 2010 at Teletorium, TEC.

VIII. AUSPI LETTERS

- A. On 27th March 2010, AUSPI submitted a letter to Secretary, DoT regarding Security clearance before placement of purchase order for procuring telecom equipment / Software. This letter was written with reference to DOT letter dated 18th March 2010 and 25th March 2010.
- B. On 26th March 2010, AUSPI submitted a letter to Secretary, TRAI regarding Benefits provided to Rural Subscribers.
- C. On 25th March 2010, AUSPI submitted its comments on DUAC observations on installing communication tower in NDMC area. This was with reference to DOT's letter on Plans for installation of communication towers dated 9th March 2010.
- D. On 19th March 2010, AUSPI submitted a letter to Advisor (F), DOT requesting Spectrum charges be accepted by DOT on post quarterly basis and to re-compute the Microwave charges payable by our members as per TDSAT order and refund the excess charges.
- E. On 18th March 2010, AUSPI submitted a letter to Secretary, Department of Financial Services on Mobile Banking. AUSPI requested that :-
- i. Mobile companies should be allowed to become business correspondents by*

permitting all Unified Access Service Licensees and Cellular Mobile Telephone Service licensees to become Business Correspondents.

- ii. Mobile pre-paid instrument should be converted from Semi-closed payment system to the Open Payment System.*

- F. On 16th March 2010, AUSPI submitted a letter to Administrator, USOF regarding pending issues related to provision and expansion of Telecom Services in Rural areas.
- G. On 15th March 2010, AUSPI submitted its counter comments to TRAI on TRAI's consultation paper regarding Efficient Utilization of Numbering Resources.
- H. On 15th March 2010, AUSPI submitted a letter to Chairman TRAI requesting allotment of 2x6.25MHz Spectrum to CDMA Operators in case the Authority is considering to recommend a limit of 2x8 MHz of Spectrum for GSM Operators.
- I. On 15th March 2010, AUSPI submitted a letter to Dr. Sam Pitroda concerning Government's initiative for introduction of broadband services in all villages.

AUSPI requested that:

- i. The private sector should be fully involved in this ambitious project of Broadband deployment in all Gram Panchayats;*
- ii. The proposed USO funded subsidy scheme for broadband in rural areas should be on a technology and media neutral platform and should incentivize fast roll out to meet the objective for connecting 2.5 lakh gram panchayats in next two years.*

- J. On 13th March 2010, AUSPI submitted a letter to Secretary, DOT clarifying repeated allegations by incumbent GSM operator on Spectrum Charges.

- K. On 9th March 210, AUSPI submitted a letter to Administrator, USOF regarding Extension of period for Payment of Equated Annual Subsidy (OPEX) for RDEL Scheme.
- L. On 8th March 2010, AUSPI submitted a letter to Member (F), DoT requesting the spectrum usage charges be accepted by DOT on post quarterly basis in a similar fashion as that of revenue share license fee.
- M. On 3rd March 2010, AUSPI submitted a letter to Chairman, TRAI requesting to review the TTO (43rd Amendment) and allow service providers to adjust ILD rates depending on the market dynamics for all subscribers including subscribers with life time validity.
- N. On 3rd March 2010, AUSPI submitted a letter to Hon'ble Minister of Communication & IT requesting extension of RDEL Scheme upto 31st March 2012 and modification of existing scheme to support RDEL data related CAPEX and OPEX requirements for enabling internet access through wireless data connections in these areas.
- O. On 2nd March 2010, AUSPI submitted a letter to Wireless Advisor, WPC requesting the spectrum usage charges be accepted by DOT on post quarterly basis in a similar fashion as that of revenue share license fee.
- P. On 3rd March 2010, AUSPI submitted its comments to TRAI on TRAI's Consultation Paper on Efficient Utilization of Numbering Resources.
